Bid #1 – Cannon County Board of Education

Six locations: three (3) Elementary schools (Cannon North, Cannon South, Eastside), one (1) Middle/Elementary School, one (1) High school, and one (1) Central office, including some portables. The bid will be to spray once per month, beginning January 1, 2026, through December 31, 2027. You must be certified and licensed by the State of Tennessee for your bid to be considered.

Spraying should be done once a month at a convenient time for the schools at each location, in the cafeterias, halls, storage areas, concession stands, teachers' lounges, and any other problem areas as needed.
