The Cannon County Department of Finance is soliciting bids for mowing county property beginning April 1, 2026, and ending October 31, 2026. Mowing sites include eight (8) county properties: Courthouse (mowed weekly), Adams Bldg (side and back of building weekly), Old Jail, Ballfields/Arena (includes Rescue Squad, Extension Ofc, old Reach Bldg), Health Department, Ambulance Service, Community Center, and Convenience Center.
